10 ISSUES FOR STRATEGY AND PLANNING

10.1 Department of Health - updates:

- Aged Care Quality and Safety Commission: as part of the broader reforms occurring in the aged care sector, the Aged Care Quality and Safety Commission commenced on 1 January 2019, which provides a single point of contact for aged care concerns and queries.
 - New Aged Care Quality Standards: Assessment and monitoring against the new Aged Care Quality Standards will commence on 1 July 2019. A Self-Assessment Tool for the new Aged Care Quality Standards has been developed to assist providers to prepare for the new Standards. Self-assessment against the Aged Care Quality Standards is not required prior to 1 July 2019. However, on the basis that full compliance with the Aged Care Quality Standards will be required from 1 July 2019, services are encouraged to use the self-assessment tool to identify and address areas for improvement in order for the Aged Care Quality Standards to be met from 1 July. Before you complete your self-assessment, familiarise yourself with the Aged Care Quality Standards and Guidance and Resources for providers.
 - Self-Assessment Tool template (Word) (Note: This is not a prescribed template and you can undertake a self-assessment in your preferred format).
 - Aged Care Quality Standards Guidance for Self-Assessment (PDF)
 - The full version of the first issue of the Aged Care Quality Bulletin can be accessed here: https://www.agedcarequality.gov.au/newsletter-2019-1#checking%20your%20readiness%20for%20the%20new%20standards
- Royal Commission into Aged Care Safety and Quality: The Royal Commission opened on 18 January with a preliminary hearing, the first public hearing was held on 11 February in Adelaide continuing into the week of 18 February. At these hearings evidence will be presented which will involve key features of the aged care quality, safety and complaints system, and how that system works in practice on a general level. There will also be information about the challenges faced by the aged care system. An interim report is to be provided by 31 October 2019, and its final report no later than 30 April 2020. Further information about the Terms of Reference, as well as plans for submissions and hearings, can be found on the Royal Commission website
- Consultation streamlined consumer assessment for aged care: The department has released a discussion paper to consult with the aged care sector and interested parties on the design of the streamlined consumer assessment mode. This relates to the Government's 2018-19 Budget measure to design and implement a new framework for streamlined consumer assessments, to be delivered by a national assessment workforce from 2020. The consultation closed on Monday, 11 February 2019.
- Check for valid ACAT approval: The department has received a number of enquiries from providers about when an Aged Care Assessment Team (ACAT) assessment is required. A subsidy cannot be paid to an approved provider for providing care to a person, unless the person is approved under the Aged Care Act 1997 (the Act) as a care recipient. An ACAT assessment is required if a person is seeking access to aged care services that are funded under the Act, such as:
 - o Residential Care
 - Flexible Care in the form of Transition Care or Short-Term Restorative Care
 - o Residential Respite Care
 - a Home Care Package.

For a provider to claim subsidy for a Home Care Package, the care recipient has to also have been assigned a Home Care Package and entered into a Home Care Agreement with a provider before the take-up deadline.

- Home care and the Australian Consumer Law: Under the Australian Consumer Law, consumers have rights when buying home care products or services.
 Consumers have the right to:
 - be treated fairly and not be pressured into signing anything
 - be given accurate information before they buy

- o cancel a faulty service
- o receive a repair, replacement or refund if something goes wrong
- change provider at any time (exit fees may apply).

To assist consumers to understand their rights, the Australian Competition & Consumer Commission (ACCC) has developed a consumer brochure - Home care - know your consumer rights. You can request hard copies of the brochure to distribute to consumers by: emailing cdcproject@accc.gov.au, providing the quantity you are seeking and how you will use and/or distribute them. Limited stock is available. Resources for home care providers are available to download from the ACCC website

Specialist Dementia Care Program roll out: The Australian Government is starting to roll out the Specialist Dementia Care Program (SDCP). The program will provide care for people exhibiting very severe behavioural and psychological symptoms of dementia (BPSD), who are unable to be appropriately cared for by mainstream aged care services. The SDCP will offer specialised, transitional residential support, focussing on reducing or stabilising symptoms over time. The department has advertised a targeted grant opportunity for a prototype SDCP service. The next round of 14 SDCP grant opportunities will be advertised in early 2019. This first phase of specialist dementia care units will be operational in early 2020. Further updates will be provided as grant opportunities become available. 10.2 Local Drug Action Team for Southern Fleurieu

Email received from Johanna Milbank who is doing some work for Fleurieu Group of Justices in relation a Local Drug Action Team for Southern Fleurieu. Johanna is requesting feedback on whether alcohol and other drug abuse is a specific issue for the aged care sector in relation to employees or recruitment. Meeting attendees indicated that they were not aware of this being a specific issue.

Josephine Littlehawk, Influencer of Modern Ageing, shared her lived experience about the impact of childhood institutionalised care and also talked about the valuable advocacy work she is involved in.

13 ROUND ROBIN

Terry Mangelsdorf - Carers SA Commonwealth Respite & Carelink Centre

Carers SA, CRCC funding confirmed under some funding lines through until the end of the 19/20 financial year. Pending introduction of the Integrated Carer Support Services, (ICSS) to commence with the successful applicant for the state being online by October 2019. Carers SA tendering for successful provider, tender finishes 14 February 2019. Successful applicant will be announced end June. From that date the successful applicant will transition in and all other organisations will transition out, having three months to move clients to the new support service. Access will be via the Carer Gateway, there will be a relaunch of the gateway expected soon. All service providers should ensure their details are correct on the Gateway so clients can access appropriate service information. The Government are tendering for two hubs only, one metro and one rural. Less funds than current in this tender, to service entire state. Current funding is approximately \$14 million, new funding will be approximately \$10 million per year. The type of supports will differ in the future with a different slant on the eligibility. Carers SA recommends that clients ensure they are linking with other services for ongoing supports that are available via either My Aged Care, NDIS, and any other avenue. Carers SA advises that clients will need to look at their own personal supports, within the circles of family & friends and formulate emergency plans to fill any support gaps.

Carers SA is not experiencing a reduction of the requests for respite from clients who are engaged with NDIS, as there are still significant waits around assessment and supply of packages of support or reassessment of current plans. Carers SA encourages any clients with current plans to make contact at the nine month mark of any contract to request a review, as if this isn't a smooth transition to a newly assessed plan, funding does cease and only commence again with a new plan. Clients with Mental Health diagnosis are also being assessed by NDIS, Carers SA encourages any clients with these disabilities to progress their NDIS contact ASAP.

The Community Home Support Program Flexible Respite (CHSPFR) In-home Day/Night funding is available for respite support if the client has exhausted their HSP funding or have been assessed as eligible for HSP and waiting for this to be available, also to top up funding if waiting for a larger package to become available. Please contact CRCC in these situations.

Carers SA strongly encourages eligible clients to link through My Aged Care for ongoing services & supports and if already receiving support to review those supports for any available and eligible upgrade. There will be less funding available for 'emergency & short term' supports under the new ICSS, options will be presenting at emergency departments of hospitals.

Carers SA continues to welcome contact and referral from any provider, organisation or family carer to assist carers to be able to continue with their caring role, by providing respite assistance as required in an emergency or short term occasional capacity during the current funding round. CRCC staff can plan with both carer & care recipient, the most suitable way of meeting their respite need. Advice will be forthcoming to clients around the changes when the successful tender is announced.

CRCC has funding for GH&A, Disability, Mental Health, Severe & Profound, CHSPFR & Young Carer programs under the current funding guidelines. Please contact phone 1800 052222.

Cares SA & the CRCC will be closed on the 27 & 28 March for a whole of staff development meeting, during this time the A/H's service will address any emergency respite requests only. All other enquiries will be followed up upon return on the 29 March.

ACH Group Social Links program for 2019:

Yankalilla Art group - *Art In Focus* - has been going for a year now and is well established. The group meets Friday fortnightly from 12.30pm to 3.00pm at the Uniting Church Hall on Main South Road.

Next meeting is Friday 22 February. All levels are welcome and the group has a lovely energy where customers can immerse in the art projects (painting with water colour & acrylics currently). This has been a good respite group for customers who are caring for a spouse or other family member.

Learn, Create, Share in Yankalilla (LCS). Delivered fortnightly on Wednesdays - next meeting is 13 February. LCS has been a wonderful group offering customers a day of activities including an easy stretch session, coffee & chat, cards, crafts and a two-course lunch. Occasionally the group will go on day outings e.g. the next meeting will be a bus tour to Port Noarlunga to see The Blonde Bombshells Jazz performance. This group has the added element of offering a day of respite for carers due to its start at 10am and finish at 3pm. However if the day is too long, shorter times can be offered where for example a customer may prefer a later start or leave earlier. The LCS group also has a focus on supporting customers with significant memory loss and dementia in general. This is evident in two ways. Firstly with its experienced support worker staff (and volunteer) and secondly through the Montessori approach that the LCS group has been working with including creating valued roles and a valued social experience.

Other Social Links groups that have room for more customers across the Fleurieu include:

New Art In Focus group in Victor Harbor (started on Friday 1 February)

Café Cruisers (coffee group) – a fun group that goes to a different café/venue for coffee & cake (and sometimes includes a sort stroll) in Yankalilla and surrounding areas (Friday fortnights in the morning) Fleurieu Bus Tours each month on a Thursday – next bus tour is Thursday 14 March to The Cube – D'Arenburg Winery for a tour of the interesting building/architecture.

We have had a number of customers from Victor Harbor attend our bus tours and join the Yankalilla customers. This has been helped along by using Genesis bus group in Victor Harbor.
