2. **Dementia Friendly Communities project:** The Dementia Action Group will continue to progress our local dementia-friendly communities initiatives.

We wish to trial this initiative in 2018, using the existing infrastructure of the Caring Neighbourhood Program and the Community Connect Program. The plan is to develop and test some practical

resource tools which will provide a means for effective planning and evaluating of wellbeing outcomes. The exciting news is our application for an Age Friendly SA grant was successful, it is proposed that this funding will be used to engage a consultant to assist with development of practical resources, advise on wellbeing profiling and planning, and undertake evaluation of the project.

### Workforce Development & Training

- 3. Cultural Awareness Training:** Multicultural Aged Care hosted a Cultural Awareness seminar in Victor Harbor on Tuesday 17 October 2017 1.00 - 4.00 pm at the Flinders University Rural Clinical School. Five people attended and feedback received was very positive with all participants stating the session was informative and increased their knowledge and understanding of cultural intelligence, cultural competency and culturally appropriate care.
- 4. Keeping Connected Workshop:** BPP will be rolling out this training across SA next year. This workshop was developed around the findings from 'Alone in a Crowd' research by South Australian Mandy Stanley. The research challenges stereotypical concepts associated with old age and points to the significant health risks facing older people who live with loneliness. Concepts and issues of loneliness, community belonging and building capacity will be investigated in this interactive space to provide opportunities for you to explore how you can work with people experiencing loneliness. We have booked a session for the Fleurieu region on 13 March 2018. Further details to be advised.

9. **Legislated Review of Aged Care 2017:** The Tune Report is now available following the recent review of the Living Longer Living Better (LLLBB) reforms. The Review concludes that these reforms have successfully taken the aged care system further along the road to a consumer driven and sustainable system, but that further reforms will be needed in future. The Review outlines 38 recommendations to continue the reform process.

10. **My Aged Care Free Community Information Session:** COTA SA in partnership with Country SA PHN hosted a free community information session on Wednesday 15 November 2017 at the Gospel Centre, Victor Harbor 9.30am – 12.30pm. Community members were invited to come along and hear about the My Aged Care system, My Aged Care Support Program, Commonwealth Home Support Program, Home Care Packages, and Country SA Primary Health Network. The session was well attended by 55 community members. 26 aged care service providers from 15 organisations hosted informative/resource stalls and were available to talk with community members about the services they offer. Our two local My Aged Care Peer Champions, offering support to access My Aged Care, were also in attendance and were introduced to the community.
