#### Flourishing on the Fleurieu

1. **Flourishing on the Fleurieu Festival** – Office for the Ageing recently called for submissions of case studies which showcase age friendly programs and initiatives that highlight the innovation of local government in progressing the age friendly agendas. We submitted an article about our Flourishing on the Fleurieu Festival held in October last year which exemplified the active contribution that older people are making to our community through their participation in a range of diverse community groups. The Festival, along with the Age Friendly Business and Community Awards, were featured initiatives at the Launch of the new Age Friendly SA Strategy on 22 May at the Intercontinental Adelaide for leaders of local and state government and other key stakeholders.

#### Dementia Friendly Communities

2. **Dementia Friendly Communities project:** The Dementia Action Group will continue to progress our local dementia-friendly communities initiatives.
  - a. *Dementia Alliance:* This group will help advocate for the needs of people living with dementia, their families and carers. The Dementia Alliance will provide feedback to the Dementia Action Group to help shape future efforts to make our community more aware and inclusive of the needs of people living with dementia. We are working closely with Caring Neighbourhood Program and Community Connect Program to see how this initiative might value-add and utilise the infrastructure of these existing local social support programs.

5. **A Taste of Resilience workshop:** This three hour workshop was held at the new Community Hub in Goolwa on Tuesday 2 May 2017, with twelve people participating. Feedback was very positive with 11 out of 12 respondents rating the level to which they gained learnings or insights as "a lot" or "a great deal", 83% rated their overall satisfaction as very good to excellent.
