2018. We are working closely with Caring Neighbourhood Program and Community Connect Program to see how this initiative might value-add and utilise the infrastructure of these existing local social support programs. We are applying for an Age-Friendly grant to fund Vanessa's involvement as a Project Coordinator to shape and test a wellbeing model, develop practical resources, liaise with UniSA and coordinate student participation (if required), evaluate and report on the project. It is hoped that we can demonstrate a sustainable model that can be integrated into existing service provision which provides a means to identify core strengths of people living with memory loss, create a wellbeing profile and plan, identify empowering resources, and use a wellbeing measure to highlight the meaningful outcomes for participants.

7. **Department of Health Service Stocktake Report Sector Support and Development:** This Progress Report outlining the Taskforce compliance and reporting against our Activity Work Plan, for the period 1 January to 30 June 2017, was submitted on 14 August 2017. As mentioned, we recently received notification of the extension of Commonwealth funding for Sector Support and Development until June 2020, in alignment with CHSP funding for service provision.
8. **Integrated Care at Home Program Discussion Paper:** The Taskforce submitted a regional response to the Department of Health's Discussion Paper titled 'Future reform – an integrated care at home program' on 16 August 2017. Feedback will be used to inform government decisions on an integrated care at home program.

10. **Good Practice Guide to Consistent Assessment:** This new resource was released by the Commonwealth Department of Health in August. The purpose of the Guide is to help assessors achieve consistency in assessment by detailing good practice standards in how they record information. The Guide provides specific tips and techniques on these tasks and activities for assessors to follow at different stages of the assessment process, such as engaging with providers during the match and refer process. It addresses issues such as the audience of assessment documentation and consistent completion of the assessment summary by RAS and ACATs.
